Government's Net Revenue Collection: The First 8 Months of Fiscal Year 2025

(October 2024 – May 2025)

Ministry of Finance reports the government's net revenue collection in the first 8 months of fiscal year 2025 (October 2024 – May 2025) was 1,704,184 million Baht. The collected revenue was 12,753 million Baht or 0.7% lower than the revenue target and was 28,834 million Baht or 1.7% higher than the same period of the previous fiscal year. Automobile Tax, Corporate Income Tax and Value Added Tax (VAT) on imports were lower than the target. Revenue shortfall in the first 8 months of fiscal year 2025 was partly due to some corporates switching their annual tax filing to e – filing, which deadline was extended to early June 2025. However, State-Owned Enterprises (SOEs) remittances and revenue from other government agencies were higher than the target. The Ministry of Finance will continue to closely monitor and manage revenue collection to maintain a strong fiscal position and the ability to finance various policies of the government.
