Government's Net Revenue Collection: October 2020

Ms. Kulaya Tantitemit, Inspector of the Ministry of Finance Acting Director of the Fiscal Policy Office and Spokesperson of the Ministry of Finance, stated that the government's net revenue collection in October 2020, the first month of fiscal year 2021, was 167,358 million baht. The collected revenue was 15,487 million baht or 8.5% lower than revenue target and was 73,712 million baht or 30.6% lower than last year. Revenue collection was lower than the target due to the economic impact of coronavirus (COVID-19) pandemic and the implementation of government's tax relief measures to support individuals and businesses.

Revenue collection was significantly lower than the same month of last year due to a high base in October 2019 from a one-time change of Petroleum and Petroleum Product Tax filing, as well as remittances from State-Owned Enterprises (SOEs) scheduled in fiscal year 2019 that were postponed to October 2019.
