## Government's Net Revenue Collection: The First 4 Months of Fiscal Year 2024 (October 2023 – January 2024)

Mr.Pornchai Thiraveja, Director General of the Fiscal Policy Office and Spokesperson of the Ministry of Finance, stated that the government's net revenue collection in the first 4 months of fiscal year 2024 (October 2023 – January 2024) was 824,115 million Baht, which was 8,836 million baht or 1.1% lower than the revenue target. The revenue from the Excise Department was lower than the target as a result of the temporary tax cut on diesel and benzene fuel. Nevertheless, remittances from State-Owned Enterprises (SOEs) were higher than the target as some remittances were postponed from the previous year, while the revenue collection from the Revenue Department was higher than the target due to Value-Added Tax. Meanwhile, revenue collection was 1.8% lower than the previous year due to special revenue in the revenue base of the previous year. Excluding special revenue of 36,666 million Baht from the base of the previous year, revenue collection was 2.7% higher than the same period of the previous year.
