## Government's Net Revenue Collection: The First Half of Fiscal Year 2024 (October 2023 – March 2024)

Mr. Pornchai Thiraveja, Director General of the Fiscal Policy Office and Spokesperson of the Ministry of Finance, stated that the government's net revenue collection in the first half of fiscal year 2024 (October 2023 – March 2024) was 1,168,900 million Baht, which was 27,819 million Baht or 2.3% lower than the revenue target. The revenue from the Excise Department was lower than the target as a result of the temporary tax cut on diesel and benzene fuel as well as a slowdown in automobile consumption. However, revenue of the Revenue Department and remittances from State-Owned Enterprises (SOEs) were higher than the target as a result of growth of Value-added tax collection and postponed SOEs remittances from the previous fiscal year. Meanwhile, when compared to the same period of the previous fiscal year, revenue collection grew slightly from the previous fiscal year. After excluding special revenue of 39,131 million Baht from the base, revenue collection was 4.2% higher than the same period of the previous fiscal year.
