



END OF SUBMISSION OF POR NGOR DOR 90,91 ON 31 AUGUST 2020

The Revenue Department (RD) invites income taxpayers to file Por Ngor Dor 90, 91 within 31 August 2020. Over 2 million income earners haven't filed their income tax return (Por Ngor Dor 90,91) yet. The Revenue Department, thereby, recommends using the internet channel to file income tax return as it is easy and convenient both for full payments and instalments. Moreover, taxpayers claiming refunds can get their money back faster by using PromptPay.

Caring for the safety of taxpayers during the novel coronavirus (COVID-19) outbreak and preventing the spread of the epidemic in many areas, the Revenue Department wants to ease the burden on taxpayers of travelling to a Area Revenue Branch office by encouraging filing of personal income tax return (year 2019) by using e-filing effective until 31 August 2020.

From 1 January to 2 August 2020, 9.57 million taxpayers filed their income tax return (year 2019), while more than 2 million taxpayers have not yet to file their income tax return (Por Ngor Dor 90,91 applicants in the previous year totalled 11.57 million). The Revenue Department, thereby, urges income earners who reach the legal criteria of earnings to file their income tax return before the due date, and recommends using the electronic system for submission via the Revenue Department website: www.rd.go.th, or RD Smart Tax Application on a mobile telephone for Por Ngor Dor 91 (excluding income of spouse). This is the new normal way that income taxpayers can save time in filing their return and getting any tax refund back faster.

Taxpayers can check their tax deductions and allowances such as donations, social security fund, deposits in the government pension fund (GPF), health insurance premiums, etc., through the My Tax Account system at www.rd.go.th.
