Government's Net Revenue Collection: The First 9 Months of Fiscal Year 2025 (October 2024 – June 2025)

Ministry of Finance reports the government's net revenue collection in the first 9 months of fiscal year 2025 (October 2024 – June 2025) was 2,046,090 million Baht. The collected revenue was 30,314 million Baht or 1.5% lower than the revenue target and was 35,648 million Baht or 1.8 % higher than the same period of the previous fiscal year. Automobile Tax was lower than the target due to effects from tax measures to promote Electric Vehicles and lower taxable automobile sales, Corporate Income Tax and Value Added Tax (VAT) on imports were lower than the target due to changes in economic condition and utilization of free trade zone. However, State-Owned Enterprises (SOEs) remittances and revenue from other government agencies were higher than the target. The Ministry of Finance will continue to closely monitor the revenue collection in order to maintain economic stability and growth.
