Government's Net Revenue Collection: The First 9 months of Fiscal Year 2026 (October 2025 – June 2026)

Ministry of Finance reports the government's net revenue collection in the first 9 months of fiscal year 2026 (October 2025 – June 2026) was 2,158,531 million Baht. The collected revenue was 50,896 million Baht or 2.4% higher than the target and was 5.3% higher than the same period of last year. The revenue collection was higher than the target from (1) Value Added Tax (VAT) (2) Vayupak Fund 1 distributed additional dividends from retained earnings and the dividend paid from certain State-Owned Enterprises (SOEs) was higher than estimated and (3) premiums from the issuance of government bonds to finance the fiscal deficit. Meanwhile, the deductions especially Corporate Income Tax refund were 16,178 million Baht or 5.4% higher than the target, due to improving the tax refund process to enhance corporates' liquidity.
